# Election to fill a vacancy on the Finance Committee, in accordance with section 9, paragraph 5, of the annex to the Agreement relating to the Implementation of Part XI of the United Nations Convention on the Law of the Sea of 10 December 1982

## Note by the Secretary-General

1. The Assembly of the International Seabed Authority is invited to note that Eleanor Petch (United Kingdom of Great Britain and Northern Ireland) resigned from the Finance Committee with effect from 30 September 2021. She had been elected by the Assembly at its twenty-sixth session under the silence procedure on 29 April 2021 as a member of the Committee for the remainder of the term of Philip Dixon ending on 31 December 2021. In line with the decision of the Assembly concerning the extension of the terms of office of the current members of the Committee,<sup>1</sup> her term had been extended until 31 December 2022.

2. Section 9, paragraph 5, of the annex to the Agreement relating to the Implementation of Part XI of the United Nations Convention on the Law of the Sea of 10 December 1982 provides that, in the event of the death, incapacity or resignation of a member of the Committee prior to the expiration of the term of office, the Assembly shall elect for the remainder of the term a member from the same geographical region or group of States.

3. By a note verbale dated 1 December 2021, the Foreign, Commonwealth and Development Office of the United Kingdom informed the secretariat of the Authority of the nomination of Christopher Hilton to fill the seat on the Committee left vacant by Ms. Petch for the remainder of her term ending on 31 December 2022. The curriculum vitae of Mr. Hilton is contained in the annex to the present note.<sup>2</sup>
