### **Note by the Secretary-General**

- 1. The Assembly of the International Seabed Authority is invited to note that Onuma Hiroshi (Japan) resigned from the Finance Committee with effect from 31 March 2020. He had been elected by the Assembly at its twenty-second session as a member of the Committee for a term of five years commencing on 1 January 2017 and ending on 31 December 2021 (see ISBA/22/A/14).
- 2. Section 9, paragraph 5, of the annex to the Agreement relating to the Implementation of Part XI of the United Nations Convention on the Law of the Sea of 10 December 1982 provides that, in the event of the death, incapacity or resignation of a member of the Committee prior to the expiration of the term of office, the Assembly shall elect for the remainder of the term a member from the same geographical region or group of States.
- 3. By a note verbale dated 24 April 2020, the Permanent Mission of Japan to the Authority informed the secretariat of the Authority of the nomination of Fujimoto Shoko to fill the seat on the Committee left vacant by Mr. Onuma for the remainder of his term ending on 31 December 2021. The curriculum vitae of Ms. Fujimoto is contained in the annex to the present note.
