Consideration, with a view to approval, of applications for extensions of contracts for exploration

Decision of the Council of the International Seabed Authority relating to an application by Deep Ocean Resources Development Co. Ltd. for extension of a contract for exploration for polymetallic nodules between Deep Ocean Resources Development Co. Ltd. and the Authority

The Council of the International Seabed Authority,

Acting upon the recommendation of the Legal and Technical Commission, 1

Recalling that, on 20 June 2001, Deep Ocean Resources Development Co. Ltd. Entered into a 15-year contract for exploration for polymetallic nodules with the Authority,

Recalling also that the contract was extended for a period of five years to 19 June 2021,  $^2$ 

*Noting* that, on 3 December 2020, the Secretary-General of the International Seabed Authority received an application for a five-year extension of the contract,

Recalling section 1, paragraph 9, of the annex to the Agreement relating to the Implementation of Part XI of the United Nations Convention on the Law of the Sea of 10 December 1982,<sup>3</sup>

Recalling also the decision of the Council of the International Seabed Authority relating to the procedures and criteria for the extension of an approved plan of work for exploration pursuant to section 1, paragraph 9, of the annex to the Agreement relating to the Implementation of Part XI of the United Nations Convention on the Law of the Sea of 10 December 1982,<sup>4</sup>

Considering the report and recommendation of the Legal and Technical Commission relating to the application by Deep Ocean Resources Development Co. Ltd. for extension of the contract,<sup>5</sup>

- 1. Decides to approve the application for extension of the contract;
- 2. Requests the Secretary-General to take the necessary steps to execute the extension of the contract, with effect from 20 June 2021, by signature of an agreement in the form set out in appendix II to the annex to the decision of the Council of the International Seabed Authority mentioned above;<sup>6</sup>
- 3. *Also requests* the Secretary-General to report to the Council at its next session on the status of the extension agreement.
