Election to fill a vacancy on the Finance Committee in accordance with section 9 of the annex to the Agreement relating to the implementation of Part XI of the United Nations Convention on the Law of the Sea

Note by the Secretary-General

- 1. The Assembly is invited to note that Liu Jian (China) has resigned from the Finance Committee effective 9 April 2009. Mr. Liu was elected as a member of the Finance Committee for a term of five years beginning 1 January 2007.
- 2. Section 9, paragraph 5, of the annex to the Agreement relating to the implementation of part XI of the United Nations Convention on the Law of the Sea provides that, in the event of the death, incapacity or resignation of a member of the Finance Committee prior to the expiration of the term of office, the Assembly shall elect for the remainder of the term a member from the same geographical region or group of States.
- 3. In accordance with section 9 of the Agreement, the Finance Committee shall be composed of 15 members with appropriate qualifications relevant to financial matters. Members of the Finance Committee shall be elected by the Assembly.
- 4. By a letter dated 30 April 2009, the Permanent Mission of China to the International Seabed Authority informed the secretariat of the Authority of the nomination of Ms. Wang Quanling, Director, Environmental and Resources Division, Department of Economic Construction, Ministry of Finance of China, to fill the vacant seat on the Finance Committee.
