# Election to fill one vacancy on the Finance Committee in accordance with section 9 of the annex to the Agreement relating to the implementation of Part XI of the United Nations Convention on the Law of the Sea

### Note by the Secretary-General

- 1. The Assembly is invited to note that Zaw Minn Aung (Myanmar) has resigned from the Finance Committee effective 6 July 2012. Mr. Aung was elected by the Assembly at the sixteenth session to replace Soe Lynn Han (Myanmar) for the remainder of his term, which expired on 31 December 2011. Mr. Aung was re-elected at the seventeenth session in 2011 for a term of five years, starting at 1 January 2012 and ending on 31 December 2016.
- 2. Section 9, paragraph 5, of the annex to the Agreement relating to the implementation of Part XI of the United Nations Convention on the Law of the Sea (the "Agreement") provides that, in the event of the death, incapacity or resignation of a member of the Finance Committee prior to the expiration of the term of office, the Assembly shall elect for the remainder of the term a member from the same geographical region or group of States.
- 3. In accordance with section 9 of the Agreement, the Finance Committee shall be composed of 15 members with appropriate qualifications relevant to financial matters. Members of the Finance Committee shall be elected by the Assembly.
- 4. By a note verbale dated 6 July 2012, the Permanent Mission of Myanmar to the United Nations informed the Secretariat of the International Seabed Authority of the nomination of Han Thein Kyaw, Second Secretary of the Permanent Mission of Myanmar to the United Nations, to fill the vacant seat on the Finance Committee left by Mr. Aung for the remainder of the term of Mr. Aung ending 31 December 2016.
