Election to fill a vacancy on the Finance Committee in accordance with section 9 of the annex to the Agreement relating to the implementation of Part XI of the United Nations Convention on the Law of the Sea

Note by the Secretary-General

- 1. The Assembly is invited to note that Pradip Choudhary (India) has resigned from the Finance Committee effective 24 May 2013. Mr. Choudhary was elected by the Assembly at the seventeenth session of the International Seabed Authority as a member of the Finance Committee for a term of five years beginning on 1 January 2012.
- 2. Section 9, paragraph 5, of the annex to the Agreement relating to the implementation of Part XI of the United Nations Convention on the Law of the Sea provides that, in the event of the death, incapacity or resignation of a member of the Finance Committee prior to the expiration of the term of office, the Assembly shall elect for the remainder of the term a member from the same geographical region or group of States.
- 3. In accordance with section 9 of the annex to the Agreement, the Finance Committee shall be composed of 15 members with appropriate qualifications relevant to financial matters. Members of the Finance Committee shall be elected by the Assembly.
- 4. By a note verbale dated 26 June 2013, the Permanent Mission of India to the United Nations informed the secretariat of the Authority of the nomination of Vishnu Dutt Sharma, Legal Adviser, Permanent Mission of India to the United Nations, to fill the vacant seat on the Finance Committee left by Mr. Choudhary for the remainder of his term ending on 31 December 2016. The curriculum vitae of Mr. Sharma appears in the annex to the present document.
