Election to fill a vacancy on the Finance Committee in accordance with section 9 of the annex to the Agreement relating to the Implementation of Part XI of the United Nations Convention on the Law of the Sea of 10 December 1982

Note by the Secretary-General

- 1. The Assembly is invited to note that Vishnu Dutt Sharma (India) has resigned from the Finance Committee effective 6 February 2015. He was elected by the Assembly at the nineteenth session of the International Seabed Authority as a member of the Committee to fill the vacancy left by Pradip Choudhary (India) until the end of the latter's term, on 31 December 2016.
- 2. Section 9, paragraph 5, of the annex to the Agreement relating to the Implementation of Part XI of the United Nations Convention on the Law of the Sea of 10 December 1982 provides that, in the event of the death, incapacity or resignation of a member of the Finance Committee prior to the expiration of the term of office, the Assembly shall elect for the remainder of the term a member from the same geographical region or group of States.
- 3. In accordance with section 9, paragraphs 1 and 3, of the annex to the Agreement, the Finance Committee shall be composed of 15 members with appropriate qualifications relevant to financial matters who shall be elected by the Assembly.
- 4. By a note verbale dated 21 April 2015, the Permanent Mission of India to the United Nations in New York informed the Secretary-General of the Authority of the nomination of Madimi Koteswara Rao to fill the seat left vacant by Mr. Sharma.
- 5. The Assembly will note that, if elected, Mr. Rao will serve on the Finance Committee for the remainder of the term in question (until 31 December 2016). The curriculum vitae of Mr. Rao is provided in the annex to the present note.
