Request for observer status in accordance with rule 82, paragraph 1 (e), of the rules of procedure of the Assembly on behalf of the Deep-Ocean Stewardship Initiative

Note by the secretariat

- 1. On 24 March 2016, the Deep-Ocean Stewardship Initiative submitted a letter to the Secretary-General of the International Seabed Authority, requesting observer status in the Assembly of the Authority. The text of the letter and additional information provided by the applicant are contained in annexes I and II to the present note.
- 2. In accordance with rule 82, paragraph 1 (e), of the rules of procedure of the Assembly, non-governmental organizations with which the Secretary-General has entered into arrangements in accordance with article 169, paragraph 1, of the United Nations Convention on the Law of the Sea, and other non-governmental organizations invited by the Assembly that have demonstrated their interest in matters under consideration by the Assembly, may participate as observers in the Assembly.
- 3. Paragraphs 5 and 6 of the same rule further provide that observers referred to in paragraph 1 (e) of that rule may sit at public meetings of the Assembly and, upon the invitation of the President and subject to approval by the Assembly, may make oral statements on questions within the scope of their activities, and that written statements submitted by observers referred to in paragraph 1 (e) of that rule within the scope of their activities that are relevant to the work of the Assembly should be made available by the secretariat in the quantities and in the languages in which the statements are submitted





Annex I

Letter dated 24 March 2016 from Lisa Levin, on behalf of the Deep-Ocean Stewardship Initiative leadership, addressed to the Secretary-General of the International Seabed Authority

In accordance with part XVI, Observers, rule 82 of the rules of procedure of the Assembly of the International Seabed Authority, the Deep-Ocean Stewardship Initiative (DOSI) is seeking to participate in meetings of the Authority as an observer, including at the twenty-second session, to be held in July 2016.

DOSI seeks to integrate science, technology, policy, law and economics into advice on the ecosystem-based management of resource use in the deep ocean and strategies to maintain the integrity of deep ocean ecosystems within and beyond national jurisdictions. DOSI gathers expertise across disciplines, jurisdictions and industrial sectors to foster discussion, provide guidance and facilitate communication. As a distributed network, DOSI has leads in the United States of America, Mexico and the United Kingdom of Great Britain and Northern Ireland, and has 400 members from 38 countries, including developing countries, island States and landlocked countries.

DOSI is closely affiliated with the International Network for Scientific Investigations of Deep-Sea Ecosystems (INDEEP) and the Consortium for Ocean Leadership (COL), a United States-based 501(c)(3) non-profit organization representing a unified voice of the ocean science and technology community. INDEEP is composed of many of the deep-sea scientists who participated in the Census of Marine Life, and COL served as the secretariat for the Census of Marine Life. Highlights of DOSI activities relevant to deep seabed mining are set out in annex II to the note by the secretariat (ISBA/22/A/INF/6). DOSI looks forward to the opportunity to contribute to the work of the Authority and States parties with the goal of improving the knowledge base.
