## CREDENTIALS OF REPRESENTATIVES TO THE RESUMED FOURTH SESSION OF THE ASSEMBLY OF THE INTERNATIONAL SEABED AUTHORITY

### Report of the Credentials Committee

Chairman: Mr. Helmut Turk (Austria)

1. At its 52nd plenary meeting, on 24 March 1998, the Assembly of the International Seabed Authority appointed a Credentials Committee consisting of the following nine members: Austria, Bahamas, Belgium, China, Costa Rica, Czech Republic, Gabon, Japan and Kenya.
2. During this part of the session, the Credentials Committee held one meeting, on 25 August 1998, and elected Mr. Helmut Turk (Austria) as its Chairman for the resumed fourth session.
3. The Credentials Committee examined the credentials of the representatives participating in the current session of the Assembly. The Committee had before it a memorandum by the Secretariat dated 25 August 1998 on the status of those credentials.
4. As noted in paragraph 1 of the memorandum of the Secretariat, formal credentials issued by the Head of State or Government, the Minister for Foreign Affairs or a person authorized by the Minister had been received by the Secretariat for the representatives of the following 60 States participating in the current session of the Assembly: Argentina, Australia, Austria, Bahamas, Bahrain, Belgium, Cameroon, Canada, Chile, China, Cote d'Ivoire, Czech Republic, Egypt, Fiji, Finland, France, Gabon, Germany, Ghana, Greece, Haiti, Honduras, India, Indonesia, Ireland, Italy, Jamaica, Japan, Kenya, Kuwait, Malta, Mexico, Myanmar, Namibia, The Netherlands, New Zealand, Nigeria, Norway, Oman, Paraguay, Poland, Republic of Korea, Romania, Russian Federation, Saudi Arabia, Senegal, Slovakia, South Africa, Sudan, Sweden, The former Yugoslav Republic of Macedonia, Togo, Trinidad and Tobago, Tunisia, Ukraine,

United Kingdom of Great Britain and Northern Ireland, United Republic of Tanzania, United States of America, Yemen and Zambia.

5. As noted in paragraph 2 of the memorandum of the Secretariat, information concerning the appointment of representatives participating in the current-session of the Assembly had been communicated by means of facsimile or in the form of initialled notes verbales from ministries, embassies, permanent missions to the Authority, permanent missions to the United Nations or other Government offices or authorities by the following six States participating in the Assembly: Brazil, Costa Rica, Mozambique, Spain, Uganda and Uruguay.

6. As noted in paragraph 3 of the memorandum of the Secretariat, the credentials of the representatives of the European Community had also been received from the President of the European Commission.

7. The Chairman proposed that the Committee accept the credentials of all representatives mentioned in the memorandum of the Secretariat on the understanding that formal credentials of representatives referred to in paragraph 2 of the Secretariat's memorandum would be communicated to the Secretariat as soon as possible. The following draft resolution was proposed by the Chairman for adoption by the Committee:

"The Credentials Committee,

Having examined the credentials of the representatives to the resumed fourth session of the Assembly of the International Seabed Authority referred to in paragraphs 1, 2 and 3 of the memorandum of the Secretariat dated 25 August 1998,

Accepts the credentials of the representatives concerned."

8. The draft resolution was adopted by the Committee without a vote.

9. Subsequently, the Chairman proposed that the Committee recommend to the Assembly for adoption the draft resolution contained in paragraph 11 below. The proposal was adopted by the Committee without a vote.

10. In the light of the foregoing, the present report is submitted to the Assembly.

#### RECOMMENDATION OF THE CREDENTIALS COMMITTEE

11. The Credentials Committee recommends to the Assembly for adoption the following draft resolution:

**“DECISION OF THE ASSEMBLY RELATING TO THE CREDENTIALS OF  
REPRESENTATIVES TO THE RESUMED FOURTH SESSION OF THE INTERNATIONAL  
SEABED AUTHORITY**
