Modalities to defray the cost of participation of members of the Legal and Technical Commission and Finance Committee from Developing Countries

Report of the Secretary-General

- 1. At its eighth session, the Assembly of the International Seabed Authority requested the Secretary-General to establish, as an interim measure, a voluntary trust fund for the purpose of defraying the cost of participation of members of the Legal and Technical Commission from developing countries and members of the Finance Committee from developing countries in the meetings of the Commission and of the Committee.
- 2. In response to the Secretary-General's request to member States to contribute to the trust fund, three separate contributions were received, totalling US\$ 10,500. The Authority has established a separate account for the fund.
- 3. At its eighth session, the Assembly also decided that the Finance Committee should review the question of modalities for financing participation in the meetings of the Commission and the Committee, including the possibility of making provision from the administrative budget of the Authority.
- 4. The contributions to the voluntary trust fund received to date have been very small. The members of the Commission and the Committee, although nominated by States Parties, are elected in their individual capacity. It is therefore necessary to ensure that the members of those bodies participate in their meetings and maintain continuity of their functions during their term of appointment. It has been noticed that some of the members of the Commission and the Committee have been unable to attend the meetings in view of financial constraints related to the costs of their travel and subsistence. The estimated costs for participation of members from developing countries are indicated in the annex, which compares the costs of air travel by economy and business class, and also indicates the costs of daily subsistence allowance as applicable for Kingston. It will be noticed that, on average, annual contributions of between US\$ 120,000 and US\$ 215,000 would be required, depending upon the number of persons, the class of travel and duration of meetings.

- 5. In order to provide guidance to the Committee in setting up the modalities for funding, a brief survey was undertaken of the existing practice in some international organizations. The most relevant instance of establishment of a trust fund to defray the costs of travel and subsistence for participation in meetings is a voluntary trust fund established by the General Assembly in 2000 for the members of the Commission on the Limits of the Continental Shelf from developing States. That fund is currently operational and the available resources are modest. The procedure established by the United Nations indicates that requests by Governments of Commission members should be sent well in advance, within a specified time. The request would be dealt with on a first-come, first-served basis. Economy class tickets by the most direct route would be issued, and the daily subsistence allowance would be at the United Nations rate. All arrangements for ticketing would be undertaken by the United Nations Secretariat.
- 6. Although a voluntary trust fund on an interim basis has already been established, the contributions to that fund have been small and slow in coming. The Committee may therefore wish, in addition to the voluntary contributions to the trust, to consider the following options so as to facilitate funding:
- (a) The apportionment of a certain sum of money from the interest accrued in the general administrative fund of the Authority;
- (b) The apportionment of a specified amount, annually, from the unused portion, if any, of the budget of the previous year;
- (c) The apportionment of a specified amount from the interest of the pioneer investor fund.
- 7. The Committee may also wish to recommend that such a fund be administered by the secretariat of the Authority, in accordance with the administrative rules and procedures, and that a report be submitted to the Committee.
