It must be stated that expectations of States are very high regarding the realization of benefits that would necessarily accrue when actual mining in the "Area" commences.

Nigeria wishes to emphasize the fact that the principle of the Common Heritage of Mankind should be the overarching basis of application of the Regulations on Exploitation of Resources in the Area and should therefore be more clearly reflected in the body/operative parts of the draft Regulations.

Nigeria also wishes to remind the Authority of its earlier commitment to ensure that deep seabed mining in the Area will occur, only if it can be demonstrably shown to be beneficial to mankind.

Nigeria therefore urges the Authority to do all the needful to ensure that mining activities begin only when it is demonstrably proven that such activities will be beneficial to the mankind.

In this regard, Nigeria wishes to reiterate the submission of the African Group on the operationalization of the Enterprise, which is an important manifestation of the principle of the 'Common Heritage of Mankind'.

Nigeria urges the Authority to expedite actions leading to the operationalization of the Enterprise which is the organ of the ISA that will be charged with the mandate of overseeing all Mining activities in the Area.
