CHANGE current proposed text in ISBA/25/C/WP.1 (2019) DR 3(d)(i) as follows:

- (d) (i) Promote Protect the health and safety of human life, health and safety, with respect to activities in the Area, and related property, and property at sea and the protection of the Marine Environment:
 - 4. Please indicate the rationale for the proposal. [150 word limit]

LOSC Arts. 146 and 145 do not include "promote." Regulations must implement what is actually written in the LOSC, or risk being vulnerable to legal challenge. As *human* health and safety are covered in other maritime conventions, their inclusion *as redrafted* should be acceptable.

"Property at sea" is not found in the LOSC, whose Arts. 101 and 105 refer to "property" in regard to activities at sea only for piracy "on the high seas, or in any other place outside the jurisdiction of any State," and also apply to the Area. (The property of, e.g., the Authority, etc., is a different category.) Its inclusion *as redrafted* should be acceptable.

"Property at sea" is not a legally valid supplement under the LOSC in this context.

CHANGE current proposed text in ISBA/25/C/WP.1 (2019) DR 3(e) as follows:

- (e) Contractors, sponsoring States and members of the Authority shall cooperate with the Authority in the establishment and implementation of programmes to observe, measure, evaluate and analyse the impacts of Exploitation and related activities on the Marine Environment,
 - 4. Please indicate the rationale for the proposal. [150 word limit]

The proposed addition of "and related activities" helps avoid potential confusion on the type and scope of the activities being addressed and helps reduce the possibility of the term "exploitation" being interpreted restrictively, thereby risking excluding activities that might harm the marine environment. Such an exclusion would be incompatible with the LOSC because the full scope of its environmental provisions would remain unimplemented as required and render the regulations vulnerable to legal challenge.
