There are now 6 alternatives for the polluter pays principle. We PREFER alt 1, in which the principle is listed without further explanation as to its origins (i.e. Rio Dec). This is consistent with the way we prefer to reference the precautionary principle and the ecosystem approach – i.e. no further explanation as to origin or nature. These principles are evolving into accepted principles of international environmental law and so do not need explanation. In addition, many States embody these principles in their domestic law – and it will be more difficult to accommodate different domestic approaches if we attempt to describe the detail of these principles and approaches.
