Regulation 13.1

ICPC supports adoption of the draft text in the Council Drafting Suggestions, ISBA/26/C/CRP.1, with certain modifications. As the development and consideration of a Plan of Work by the Commission is a confidential process in which submarine cable operators have no right of information or the ability to initiate coordination with the contractor, it is critical that the Commission ensure coordination between a Contractor and a submarine cable operator at an early stage when it can be meaningful.

- In some cases, data and resources about submarine cables and pipelines are commercially available for a fee. ICPC believes they should also be used by contractors (as reflected in paragraph 1(g)(i)), just as submarine cable operators use commercially available data and resources to plan routes and assess risks.
- No Guidelines have been proposed or developed in this area, and the Guidelines should not limit identification activities (as reflect in paragraph 1(g)(i)).
- The proposed modifications seek to future-proof the text and make it less prescriptive by including less prescriptive examples of coordination and protection mechanisms in paragraph 1(g)(ii).

 - (d)(alt.) Provides for Exploitation activities to be carried out with <u>due and</u> reasonable regard for other activities in the Marine Environment, as referred to in articles 87 and 147 of the Convention, including inter alia navigation, the laying of cables and pipelines, the right to maintain and repair existing submarine cables and pipelines, fishing and marine scientific research;

ICPC supports the adoption of the text in paragraph 4(d)(alt.) of the Council Drafting Suggestions, ISBA/26/C/CRP.1, as it properly references articles 87 and 147 and also accounts for maintenance and repair (not just laying) of submarine cables.

- The text in paragraph 4(d) omits these critical provisions, and also inappropriately references Guidelines, which should not be a substitute for, or condition, compliance with the Convention.
- Article 87 of the Convention references "due regard." This has the same meaning as "reasonable regard," but both terms should be referenced here to ensure consistency with the Convention.
