3) The [Secretary-General] [Inspectorate] shall report acts by any person of violence, intimidation or abuse against or the wilful obstruction or harassment by any person of an Inspector [in the course of their duty] or the representative of a sponsoring State, any other State Party, or other party concerned who accompanies the Inspector, as identified in paragraphs 2 and 5 of regulation 96, by any person or the failure by a Contractor to comply with regulation 96 [to the Secretary-General]

On paragraph 1 of draft regulation 100, without prejudice to Micronesia’s views on the rest of the paragraph, Micronesia proposes the insertion of the word “adjacent” as an additional modifier to the phrase “coastal State or States,” in order to align the text here with other draft regulations that address the rights and interests of [relevant][adjacent] coastal States that could be impacted by activities in the Area, including activities that are subject to an inspection under this Part because they could pose a threat of Serious Harm to the Marine Environment, mindful that the Marine Environment encompasses maritime areas within the national jurisdiction of

coastal States that are adjacent to locations where activities take place in the Area. On paragraph 3 of draft regulation 100, without prejudice to Micronesia's views on the rest of the paragraph, Micronesia proposes text that clarifies that the reporting covered in the paragraph must apply to acts of violence, abuse, intimidation, obstruction, or harassment against not just an Inspector, but also against representatives of sponsoring States, other States Parties, or other parties concerned who are authorized under draft regulation 96 to accompany the Inspector. This amendment to paragraph 3 is also necessary in order to be in alignment with the current draft of paragraph 3bis in this draft regulation 100.
