

Status of the Protocol on Privileges and Immunities of the International Seabed Authority

The Protocol entered into force on 31 May 2003 in accordance with article 18 which reads as follows:

- "1. The Protocol shall enter into force 30 days after the date of deposit of the tenth instrument of ratification, approval, acceptance or accession.
- 2. For each member of the Authority which ratifies, approves or accepts this Protocol or accedes thereto after the deposit of the tenth instrument of ratification, approval, acceptance or accession, this Protocol shall enter into force on the thirtieth day following the deposit of its instrument of ratification, approval, acceptance or accession."

The Protocol was adopted by consensus at the fifty-fourth meeting of the Assembly of the International Seabed Authority in Kingston, Jamaica, on 26 March 1998, during the first part of the fourth session. In accordance with its article 15, the Protocol was opened for signature by all Members of the Authority at the Headquarters of the International Seabed Authority in Kingston, Jamaica, from 17 to 28 August 1998. The formal signing ceremony was held on 26-27 August 1998. Subsequently, it was opened for signature through 16 August 2000 at United Nations Headquarters in New York.

¹ Argentina made the following declaration upon accession: "The Republic of Argentina will accord such privileges and immunities as are specified in the Protocol on the Privileges and Immunities of the International Seabed Authority, adopted in Kingston on 27 March 1998, to members of the Secretariat of the International Seabed Authority who are nationals or permanent residents in its territory to the extent necessary for the adequate fulfillment of their duties. With regard to fiscal and customs matters those members will be subject to the national norms applied in its territory."

¹ Chile made the following reservation upon ratification: "The Government of Chile expresses a reservation with respect to article 8, paragraph 2 (d) of the Protocol, as that provision will not exempt its nationals from national service obligations."
