• Environmental Effect – We generally support the definition of "Environmental Effect" but we are concerned the current definition may be too broad for all uses. For example, the EIA and EIS will deal with key environmental effects (as determined through an Environmental Risk Assessment), and not every effect (i.e. the EIA and EIS will not consider in detail effects that are considered trivial or insignificant). There may be a need to differentiate environmental effect (i.e. any effect) from Environmental Effect (which perhaps means material effect?) in the regulations. This likely needs further discussion. We note, too, that Cumulative Effects now has a separate definition and so does not need to be included in this one.

Comment: We suggest further discussion by the Council, based on this draft definition. We note, however, that full restoration to pre-disturbance conditions is an unrealistic aim for land-based mining and it is unlikely to be realistic for deep-seabed mining. Rehabilitation (see suggested definition above) to some agreed state is a more realistic environmental goal/objective post disturbance.
