- (a) We would like to pay attention that the mentioned in this paragraph International Seabed Authority Reporting Standard for Reporting of Mineral Exploration Results Assessments, Mineral Resources and Mineral Reserves in Annex V of the document ISBA/21/LTC/15 is a part of the Guidelines, despite of the title Standard. This collision need to be resolved. In any case, from practical point of view the reference to the specific document would be better to exclude from the Regulations.
- (b) We tried to correspond this paragraph with paragraph 17 of the Annex I
