Status of the draft regulations on exploitation of mineral resources in the Area and index of relevant documentation

Note by the Secretariat

I. Introduction

- 1. The Council is currently considering draft regulations on exploitation of mineral resources in the Area (ISBA/25/C/WP.1), which were prepared by the Legal and Technical Commission and submitted to the Council in 2019 following an iterative process of development and consultation that began in 2011, when the representative of Fiji requested the Council to begin consideration of regulations for the exploitation of mineral resources of the Area (ISBA/17/C/22).
- 2. A complete set of regulations had been prepared by the Commission and submitted to the Council pursuant to article 165, paragraph 2 (f), of the United Nations Convention on the Law of the Sea. In the process of developing the draft regulations on exploitation, several expert workshops were held, that involved the preparation of many expert studies and discussion papers. Five rounds of open stakeholder consultations were undertaken from 2014-2019. The Commission also prepared drafts of 10 standards and guidelines to support the implementation of the future regulations. These draft standards and guidelines have been through two stakeholder consultations during 2020 and 2021.
- 3. The main steps taken in the preparation of the draft regulations from 2011 to 2023 are listed in annex I. Annex II provides a complete list of relevant documents, reports and studies relating to the preparation of the draft regulations during the same period.
- 4. The purpose of the present report is to outline the current status of the draft regulations on exploitations, updating the status previously reported in <u>ISBA/26/C/44</u>, to guide the work pursuant to the road map for continued work as contained in <u>ISBA/28/C/24</u>, with a view to the adoption of the draft regulations and associated phase 1 standards and guidelines.

II. Review of the development process from 2017 to August 2023

- 5. At the twenty-third session, in 2017, the Council agreed on a timeline for the adoption and approval of the draft regulations by July 2020. At the same session, the Assembly endorsed a revised schedule of meetings for 2018, 2019 and 2020 designed to enable the Commission and the Council to deliver the regulations in accordance with the road map. The revised schedule of meetings envisaged two annual meetings of two weeks each for the Commission and two annual meetings of one week each for the Council.
- 6. In accordance with the revised schedule of meetings, the Commission and the Council worked in parallel on the draft regulations during 2018 and 2019. At the twenty-fourth session, in 2018, the Council reiterated its view that the draft regulations should be adopted as a matter of urgency, commended the Commission for the considerable work that it had accomplished and encouraged it to pursue its efforts at its meetings in 2019.³ The Council also provided the Commission with comments on the draft regulatory text under consideration⁴ and initiated a consultation process to enable all stakeholders to submit specific comments in writing for consideration

by the Commission.⁵ The Commission reviewed those comments and finalized its recommendations on the draft regulations at its meetings during the first part of the twenty-fifth session.⁶

- 7. One of the key outcomes of the stakeholder consultation held in 2019 was that many stakeholders agreed that standards and guidelines implementing the draft regulations had to be developed in parallel with the regulatory text. Stakeholders also advocated putting in place critical phase 1 standards and guidelines by the time of adoption of the regulations. Such was the importance of that issue that a separate report was prepared for the Council, which included a proposed priority list of standards and guidelines to be developed. To further support the work of the Commission and the Council, an international workshop on the development of standards and guidelines was held in Pretoria in April 2019 (between the first and second parts of the twenty fifth session).
- 8. During the second part of the twenty-fifth session, the Council considered the report of the Chair of the Legal and Technical Commission, which incorporated recommendations for the development of standards and guidelines, including the list of documents to be developed under phase 1.9 The Council held a discussion on the draft regulations and adopted a decision in which, inter alia, it expressed its intention to ensure the thorough and timely development of the draft regulations, bearing in mind that the necessary standards and guidelines should be developed before the adoption of the draft regulations, and it requested the Commission to work on standards and guidelines as a matter of priority. The Council also decided that additional written comments on the draft regulations, including specific drafting suggestions, could be sent to the secretariat no later than 15 October 2019, and it requested the secretariat to prepare a compilation of the proposals and observations submitted by members of the Council and a compilation of proposals and observations submitted by other States members of the Authority, observers and other stakeholders, for consideration by the Council at its twenty-sixth session, in 2020.
- 9. The first part of the twenty-sixth session of the Council took place in February 2020. The Council resumed its consideration of the draft regulations, which it had commenced at the twenty-fifth session, and considered parts IV, V and VI of the draft and the related annexes IV, VII and VIII. The Council also adopted a decision on working methods to advance discussions on the draft regulations, ¹² in which it decided to establish three informal working groups on thematic issues, each to be led by a facilitator. In addition to the existing Openended Working Group in Respect of the Development and Negotiation of the Financial Terms of a Contract ("OEWG"), ¹³ the groups, as of August 2023, are:
- (a) The Informal Working Group on the Protection and Preservation of the Marine Environment, facilitated by Ms. Raijeli Taga (Fiji);
- (b) The Informal Working Group on Inspection, Compliance and Enforcement, facilitated by Ms. Maureen Tamuno (Nigeria);

I The Informal Working Group on Institutional Matters, facilitated by Gina Guillen-Grillo (Costa Rica) and Salvador Vega Telias (Chile).

During the first part of the twenty-seventh session, in 2022, the President of the Council provided a briefing paper ¹⁴ of the work of the Plenary concerning the draft regulations and the consideration of phase one draft standards and guidelines. The briefing paper set out how the Council would progress the work on aspects of the draft regulations that were not being reviewed within the context of any of the working groups. Based on the briefing paper, it was agreed by the Council during its meeting in March 2022 that the parts of the draft regulations not covered by any of the informal working groups would be reviewed by the plenary in an informal format. elements are included in the President's text. 15 Several proposals were provided to these sections of the draft exploitation regulations. To collect and compile these proposals, the President of the twenty-seventh session provided a full collation of the proposals in a President's text, which has continuously been updated. 16

III. **Process since March 2020**

- 11. The Council requested the Chair and the Facilitators to report on the progress made in their work at the informal meetings in the period from March 2020 and onwards. Below is a summary of the progress made during the respective sessions. The reporting can also be accessed in further details in the Statements of the President.¹⁷
- Α. Progress made during the twenty-sixth session of the Council
- 12. Since February 2020, due to the pandemic, the Council was unable to meet in person and, accordingly, no progress could be made in any of the newly established informal working groups.
- In relation to the work of the OEWG, a series of informal webinars were held on 9, 11 and 12 June and 28 October 2020, 18 in which the methodology and outcomes of studies relating to a comparative analysis of the financial aspects of deep seabed mining and land-based mining were presented, as requested by the Council.
- In addition, the Secretariat was able to continue its work on the preparation of studies and reports concerning the draft regulations, as requested by the Commission and the Council, respectively. This included the preparation of studies and reports concerning: (a) matters related to insurance; (b) the environmental compensation fund¹⁹; (c) competencies of the International Seabed Authority and the International Maritime Organization²⁰; (d) the environmental performance guarantee²¹; (e) remote monitoring in the context of inspections²²; (f) potential impacts on land-based producers²³; and (g) the application of International Labour Organization instruments to activities in the Area.24
- 15. Concerning the phase 1 standards and guidelines, during 2020 and 2021, the Commission met remotely and developed the following draft standards and guidelines, which were open to comments from stakeholders: (a) draft guideline on the preparation and assessment of an application for the approval of a plan of work for exploitation; (b) draft standard and guidelines on the development and application of environmental management systems; (c) draft standard and guidelines on the form and calculation of an environmental performance guarantee; (d) draft guidelines for the establishment of baseline environmental data; (e) draft standard and guidelines for environmental impact assessment process; (f) draft guidelines for the preparation of an environmental impact statement; (g) draft guidelines for the preparation of environmental management and monitoring plans; (h) draft guidelines on tools and techniques for hazard identification and risk assessments; (i) draft standard and guidelines for the safe management and operation of mining vessels and installations; and (j) draft standard and guidelines for the preparation and implementation of emergency response and contingency plans.²⁵ A stakeholder consultation took place from 20 August to 20 October 2020. Furthermore, a consultation took place from 8 April to 3 July 2021.26
- The Council resumed face to face meetings in Kingston, Jamaica, from 6 to 10 December 2021 under the Presidency of Rear Admiral (retired) Mohammad Khurshed Alam (Bangladesh).²⁷ The Council took note of

the decisions it had taken under silence procedure in 2020 and 2021²⁸ and adopted a roadmap to advance the work on the draft regulations on exploitation of mineral resources in the Area in 2022 (ISBA/26/C/13/Add.1, Annex).²⁹

- B. Progress made during the twenty-seventh session of the Council
- 17. The first part of the twenty-seventh session of the Council was held from 21 March to 1 April 2022. Tomasz Abramowski (Poland) was elected as the President of the Council for the twenty-seventh session. As a matter of priority, the Council continued to consider the draft regulations on the exploitation of mineral resources in the Area. ³⁰
- 18. The OEWG held its fourth meeting in March 2022. During the meeting, Richard Roth from Massachusetts Institute of Technology (MIT) presented a summary of benefits and disadvantages of four different options for a payment system. After that, the group carried out discussions on that basis. During the same meeting, some delegations suggested that a study be carried out on environmental costs. Finally, it was agreed that the Chair should prepare a Chair's draft text for a payment system. Such a text was released ahead of the second part of the twenty-seventh session, in July 2022. The group held its fifth meeting in July 2022 when the group managed to conduct discussions of the different payment options and partially read the Chair's text. The negotiations of the Chair's text were resumed and finalized during the group's sixth meeting under the third part of the twenty-seventh session. During the third part of the twenty-seventh session, Richard Roth from MIT gave a presentation on the financial payment system modelling for polymetallic nodules, which was followed by a presentation by the Intergovernmental Forum on Mining, Minerals, Metals and Sustainable Development (IGF) on Offshore Indirect Transfers. The latter was based on a request by a group to implement regulation on a tax or levy on the transfer of rights.
- 19. The Informal Working Group on the Protection and Preservation of the Marine Environment met for the first time since its establishment and held five meetings on 23, 24, 25 and 28 March 2022. The group had conducted a webinar in February 2022 with a view to receiving general comments on the Facilitator's text. ³² The group managed to conduct a reading of the entire text during the meeting in March 2022, and it was considered a solid basis for future negotiations. The Facilitator agreed to prepare a revised Facilitator's text for the second part of the twenty-seventh session. ³³ In June 2022, the group held a webinar concerning the difference between the Sustainability Fund and the proposed Environmental Compensation Fund, as requested by the Council. ³⁴ During the second part of the session in July 2022 the reading of the Facilitator's revised text was commenced. During the same meeting, a document of 10 June 2022 was presented concerning the normative environmental thresholds for deep-seabed mining. ³⁵ The reading of the revised text was finalized during the third part of the twenty-seventh session, and the Facilitator promised to provide a further revised text ahead of the twenty-eighth session.
- 20. The Informal Working Group on Inspection, Compliance and Enforcement held its first and second meetings on 28 and 29 March 2022. Discussions were carried out in respect of the creation of the institutional framework through which effective inspection, compliance and enforcement could be undertaken. The Facilitator agreed to provide a Facilitator's text for the July meeting. This text³⁶ was warmly welcomed during the groups meeting on 20 July 2022, where the group managed to finalize the reading. A Facilitator's revised text³⁷ was provided for the third part of the twenty-seventh session, where the group managed to finalize the reading.
- 21. The Informal Working Group on Institutional Matters held its first and second meetings on 29 and 30 March. The co-facilitators had prepared a presentation and described the scope of the work and the way forward. For the meeting in July 2022, the co-facilitators had prepared a text³⁸ and a mapping of the mandates of ISA

organs,³⁹ which was followed-up with a revised text ahead of the meeting of the group during the third part of the twenty-eighth session in November 2022.⁴⁰

- 22. Concerning the phase 1 standards and guidelines, it was agreed that the Commission would review stakeholder comments from the stakeholder consultations in 2020 and 2021 and finalize its revision of the phase 1 standard and guidelines based on the results of the consultations. A report of the Chair of the Commission was subsequently issued, providing reasons and methodology for the Commission's revisions. The revised standards and guidelines were issued in January 2022⁴² and presented during the first part of the twenty-seventh session in March 2022. During the Council meeting in March, some delegations expressed the view that the discussion of the draft regulations should be conducted in parallel with that of the draft phase 1 standard and guidelines, with cross-referencing. Some delegations on the other hand expressed the preference for the draft phase 1 standard and guidelines to be considered after the draft regulations were "stable". The revised standards and guidelines are currently under consideration by the Council.
- As mentioned above, under para 10, it was agreed that the parts of the draft regulations and standards for phase I, which are not allocated to any informal working groups of the Council, would be handled in an informal setting. Based on that, the President of the Council introduced the President's text during the third part of the twenty-seventh session. ⁴³ The text contains a compilation of all outstanding elements with an implementation of all proposals received from delegations and observers.
- 24. During the second part of the twenty-seventh session, the Council requested the Secretariat to commission a study on the internalization of environmental costs of exploitation activities in the Area⁴⁴ and commission the work on the development of binding environmental threshold values.⁴⁵
- 25. Finally, at the third part of the twenty-seventh session, the Council adopted a new roadmap for the twenty-eighth session (ISBA/27/C/21/Add.2, Annex II).⁴⁶
- C. Progress made during the twenty-eighth session of the Council
- 26. The twenty-eighth session of the Council commenced on 16 March 2023. The Council elected Juan José Gonzalez Mijares (Mexico) as President.
- 27. The OEWG held its seventh meeting during the first part of the twenty-eighth session. The Chair presented a Chair's revised text, which was welcomed by the participants and the reading was successfully finalized. The During this meeting, two conceptual topics were presented and updates were provided in respect to the financial model. Alexandra Readhead and Thomas Lassourd of IGF gave a presentation on some general aspects, including on the interaction between option 3 and option 4 for the payment system and sponsoring State taxes. IGF also gave a presentation on the financial implications of a tax or levy on transfer of rights under a contract. He also gave a presentation on the topic of the possible deduction of domestic and sponsoring State tax from (higher) royalty rates. During the second part of the twenty-eighth session, and the group's eighth meeting, the Chair provided a further revised text, and discussions were in particular centred around the mechanism to develop equalization measures and the continued issue of a tax or levy on transfer of rights under a contract. It was agreed that the Chair will provide a third revised text for the November session.
- 28. The Informal Working Group on the Protection and Preservation of the Marine Environment met from 20 to 22 March 2023, where the facilitator presented her further revised text⁴⁹ with a reminder to the participants to set high standards, as in article 145 of the United Nations Convention on the Law of the Sea. During the reading, some cross-cutting issues were identified, including generic referencing, clarified definitions,

streamlining and coherence of the text. Furthermore, consideration was also given regarding the recently agreed draft agreement under the United Nations Convention on the Law of the Sea on the conservation and sustainable use of marine biological diversity of areas beyond national jurisdiction to find consistency and alignment somehow. Several intersessional working groups were established during the meeting and it was agreed that they would provide input for the Facilitator's third revised text ahead of the second part of the twenty-eighth session. The Facilitator's third revised text was presented during the meeting in July 2023. It was well received, and the group managed to conduct a reading of draft regulations 43 to 48. During the meeting, it was agreed that greater focus should be placed on the standards and guidelines and that the Facilitator would prepare a matrix that would contain what elements could go into existing standards and guidelines and what new standards and guidelines should be provided based on the development of the work in the group. It was also agreed that the Facilitator would prepare a fourth revised text and that the reading would resume from draft regulation 49.

- 29. In the Informal Working Group on Inspection, Compliance and Enforcement, the Facilitator presented her further revised text during the meeting of the group in March 2022.⁵¹ One of the main topics of the group was the discussion of the most appropriate inspection mechanism, cf. article 162(2(z) of the United Nations Convention on the Law of the Sea. Several different views were presented, and an intersessional working group volunteered to try to seek consensus between the different views. During the second part of the twenty-eighth session, a hybrid model was proposed, according to which a Compliance Committee is established within the Legal and Technical Commission. During the same meeting, the Facilitator's third revised text was presented.⁵² The group did not decide on an inspection mechanism, but the group agreed to continue the discussions based on the hybrid model.
- 30. The Informal Working group on Institutional Matters resumed its reading of the co-facilitators revised text ath the meeting in March 2023.⁵³ A new text (compilation for the resumed reading) was provided for the meeting in July 2023.⁵⁴ During the meeting in July 2023, the co-facilitators also made a presentation on effective control ahead of a webinar concerning the same topic. A webinar was held on 1 September where presentations were made on effective control with a focus on implications for Sponsoring States and their obligations to regulate the contractors.⁵⁵
- 31. In respect of the President's text, the first reading was reassumed and was finalized during the first part of the twenty-eighth session. This reading was based on an updated President's text.⁵⁶ In July, the President presented a revised text, that contained a thorough streamlining, which was appreciated by delegations and observers.⁵⁷
- 32. During the third part of the twenty-eighth session, the Council considered a draft roadmap prepared by the President for the future organization of the Council's work on the draft regulations and associated standards and guidelines. These discussions were carried out based on the President's briefing note of 29 June 2023.⁵⁸ On 21 July 2023, the Council adopted a decision on a timeline and modalities for the work of the Council until July 2024 and endorsed a new roadmap.⁵⁹
- 33. During the meetings in March and July 2023, several delegations expressed an interest in making available a consolidated negotiating text of the draft regulations, which would identify areas of overlap, duplication and omission and address the need for harmonisation between the various provisions and related annexes. It was thus agreed in the roadmap, to issue such a consolidated negotiating text after the third part of the twenty-eighth session. It was also agreed that ahead of the meeting in November 2023, a collation of the current texts of the informal working groups will be provided.

34. During part III of the twenty-eight session, the Council considered a proposal submitted by the African Group and adopted a decision relating to the establishment of the position of an interim director general of the Enterprise. ⁶⁰ Finally, the study on the environmental costs of exploitation activities in the Area, requested by the Council (<u>ISBA/27/C/43</u>) was released on 31 May 2023, ⁶¹ together with a note by the Secretariat on the background and the solicitation and selection process. ⁶²
