Relinquishment of a seat in the Council of the International Seabed

Authority (1996-2023)

- 1. In accordance with section 3, paragraph 15, of the Annex to the 1994 Agreement, the Council shall consist of 36 members elected by the Assembly.
- 2. However, in attempting a formula for equitable geographic distribution among the membership of the Council, the Assembly agreed on the following formula:¹

Groups	Seats
Group of African States	10
Group of Asia-Pacific States	9
Group of Eastern European States	3
Group of Latin American and Caribbean States	7
Group of Western European and Other States	8

- 3. Since the total number of seats allocated according to that formula is 37, it is understood that, in accordance with an understanding reached in 1996,² each regional group other than the Eastern European Group will relinquish a seat in rotation. The regional group which relinquishes a seat will have the right to designate a member of that group to participate in the deliberation of the Council without the right to vote, during the period the regional group relinquishes the seat.
