A Contractor shall keep [at a place agreed between the Contractor and the Compliance Committee, and make available for inspection and audit in accordance with these regulations, a complete and proper set of books, accounts and financial records, consistent with internationally accepted accounting principles, which must include information that fully discloses [all revenue and] actual and direct expenditures [liabilities] for Exploitation, including capital expenditures and operating costs and such other information as will facilitate an effective audit of the Contractor's expenditures and costs.

[1.bis The Contractor shall keep the books, account, and records pursuant to paragraph 1-at a place agreed between the Contractor and the [Compliance Committee], and shall make them available for inspection and audit in accordance with these regulations.]

• We oppose the requirement in Draft Regulation 39(1) and (1.bis) that Contractors seek the agreement of the Compliance Committee as to the appropriate place for storing their records. Regulation 39(3) to ensure that Contractors have appropriate flexibility with this
