## Regulation 14 [IWG IM]

## Amendments to the proposed Plan of Work

1. At any reasonable time prior to making its recommendation to the Council and as part of its consideration of an application under Regulation 12, the Commission may:

(a) Request the applicant to provide additional information on any aspect of the application within 30 Days of the date when the application is first considered prior to making a recommendation, while ensuring that any such request is necessary, proportionate and will not prevent the Commission from meeting the approval timeline set out in the relevant Standard; and [...]

## 5. Please indicate the rationale for the proposal. [150-word limit]

- We are concerned that the proposed amendments to Draft Regulation 14(1)(a) could inadvertently result in repeated requests and review loops in the consideration of applications. This could result in the addition of significant time and effort to the Commission's work and also impose unclear regulatory burden on applicants (in particular noting stakeholder consultation requirements).
- It is important that the application process and review procedure is clear from the outset so that applicants have certainty regarding how their application will be processed. As such, we propose amendments to this sub-paragraph to ensure that requests for additional information are predictable and efficient and do not result in endless consideration of applications.
