Regulation 93 bis [President's Text]

Stakeholder Consultation

7. During the consultation period, the applicant or Contractor shall <code>[endeavour to] conduct</code> engagement with States and <code>[potentially directly affected and interested]</code> Stakeholders <code>public engagement</code>, <code>and in accordance with [Regulation 93 ter] applicable Standards, and taking into <code>[consideration]</code> Guidelines. The Secretary General may, <code>in consultation with the relevant applicant or Contractor</code>, direct the applicant or Contractor to conduct such meetings, workshops and engagement <code>or facilitate such meetings</code>, <code>workshops and other forms of engagement</code>.</code>

The applicant or Contractor shall consider the submissions received and may revise the documentation that was the subject of consultation. The applicant or Contractor shall prepare a written response to consultation that collates and responds to the [substantive] and relevant comments expressed in submissions and includes an explanation of any revisions to the document and how those revisions respond to [substantive] and relevant comments expressed in the submissions. The applicant or Contractor shall submit the written response, with any revised documentation, to the Secretary-General for transmission to the Commission.

- We support the applicant or Contractor being required to endeavour to engage with States and interested Stakeholders and propose amendments to Draft Regulation 93bis (7) to clarify this obligation.
- We also consider that given that holding meetings or workshops or other forms of engagement activities will have cost implications, the Secretary-General should engage with applicants and Contractors prior to directing them to undertake any specific activity or indeed consider facilitating such activities itself.
- In relation to Draft Regulation 93bis (9), we support fulsome and appropriate consultation with stakeholders and requiring contractors to respond properly to substantive and relevant comments. However, contractors should not be required to respond in writing to irrelevant or vexatious comments, even if these may be substantive. As such, we propose amending Draft Regulation 93bis(9) to insert a requirement of relevance.
