8. Background information on the organization

"[The Ocean and Us](#)" is a non-governmental organization (NGO) focused on the protection of marine ecosystems through advocacy for strict international environmental law, and the inclusion of the feminine and collective perspectives in ocean decision making. We believe that a diversity of voices is crucial to our mission to safeguard a healthy ocean. We actively engage and respect the knowledge, contributions, and needs of global communities, especially those directly affected by ocean issues. Established in 2017, the organization is based in The Hague, Netherlands, with a particular focus on high-seas biodiversity, sustainable fisheries, and the preservation of marine ecosystems in areas beyond national jurisdiction. "The Ocean and Us" works to ensure healthy oceans for future generations by influencing policy, promoting science-based decision-making, and supporting marine conservation efforts. Our primary areas of focus include ocean literacy, marine biodiversity, the prevention of harmful marine activities such as deep-sea mining, and the protection of vulnerable ecosystems from overexploitation.

We do this through a (gender) inclusive lens. To this end “The Ocean and Us” brings together women-expert voices through the Women4Oceans platform (a project of “The Ocean and Us”).

Yes, "The Ocean and Us" is a member of the Deep Sea Conservation Coalition (DSCC), which has observer status with the International Seabed Authority (ISA).

The founder, Farah Obaidullah has participated in numerous multilateral fora including the European Parliament, the United Nations Framework Convention on Climate Change (UNFCCC), the recently adopted BBNJ (Biodiversity Beyond National Jurisdiction) treaty process, the Convention on Biological Diversity (CBD) and the International Seabed Authority Assembly proceedings in 2023.

B. Interest in matters under consideration by the Assembly

"The Ocean and Us" is dedicated to the protection of marine ecosystems and ensuring that seabed activities under the jurisdiction of the ISA are carried out in a manner that prevents irreversible damage to biodiversity. Our organization actively contributes to the development of marine environmental policies and best practices that align with the work of the ISA, especially in the context of deep-sea mining. Through collaboration with scientific experts, we seek to provide data-driven insights and recommendations for the sustainable management of deep-sea resources. We also engage with local and global stakeholders to raise awareness of the importance of marine conservation and responsible seabed governance. At a national level, we engage in particular with the Netherlands government and Dutch political parties. We expect this work to expand in the following years.

14. Briefly outline whether and how the purposes or activities of the organization relate to the work of the Authority.

Our core mission aligns with the ISA's mandate to ensure the sustainable and equitable use of deep-sea resources. "The Ocean and Us" focuses on preventing environmental degradation in the high seas and areas beyond national jurisdiction. Our advocacy for precautionary approaches to marine resource extraction directly supports the ISA's goal of developing responsible regulations for seabed mining that safeguard the environment. Additionally, our commitment to promoting the protection of marine biodiversity, with a particular focus on feminine and collective perspectives, makes us a valuable (and unique) contributor to the ongoing discussions on the protection of the marine environment.

15. Briefly outline whether and how your organization intends to contribute to the work of the Authority, for example by providing specialized information, advice or expertise, or by identifying or helping to procure the services of experts or consultants.

"The Ocean and Us" intends to offer guidance on sustainable deep-sea resource management by providing, where possible, scientific, legal, and civil society perspectives, as well as policy recommendations. We will seek to contribute to discussions on the development of environmental regulations for seabed activities, with a focus on the precautionary principle, ecosystem resilience, and long-term conservation outcomes. In particular, we will bring forward feminine and collective perspectives to enrich and balance discussions. Additionally, leveraging our connections in scientific and legal communities enables us to assist the ISA in obtaining specialized information and expertise on key issues such as the environmental impact and public perceptions of deep-sea mining and the governance of the Area.

Briefly outline whether and how your organization has the expertise and the capacity to contribute, within its field of competence, to the work of the Authority, in particular in connection with the law of the sea, the protection of the marine environment, the offshore and deep-sea mining industry, technology, minerals processing and marketing, activities in the Area and marine scientific research in the Area.

Our organization is able to support the ISA in addressing complex environmental challenges related to the law of the sea, particularly in areas beyond national jurisdiction and public perceptions relating to the common heritage of humankind. "The Ocean and Us" founder has over two decades of experience in ocean advocacy including UN processes related to the Law of the Sea. Where relevant and deemed necessary "The Ocean and Us" will seek to bring in capacity to conduct research on the environmental impacts of deep-sea activities and provide actionable recommendations to mitigate these impacts.

"The Ocean and Us" is committed to supporting the ISA's capacity-building initiatives by sharing scientific knowledge, and collaborating with member states to enhance their understanding of marine resource management. In particular with our global network of women ocean experts, we aim to engage in the ISA's Secretary-General's awards and contribute to voluntary commitments that enhance capacity in marine environmental protection with a focus on boosting diverse voices in discussions pertaining to the deep-seas and areas beyond national jurisdiction. Our unique experience in elevating women's contributions and participation combined with our deep commitment to ocean literacy and awareness programs in marine conservation will aid the ISA in strengthening global capacity in this field.
