Other matters

Indicative scale of assessed contributions to the administrative budget for the second year of the financial period 2025–2026

Note by the secretariat

1. In accordance with the United Nations Convention on the Law of the Sea and the Agreement relating to the Implementation of Part XI of the United Nations Convention on the Law of the Sea of 10 December 1982, the administrative expenses of the International Seabed Authority are to be met by assessed contributions of its members until the Authority has sufficient funds from other sources to meet those expenses.
2. The General Assembly, in its resolution [79/249](#) of 24 December 2024, resolved to implement a new scale of assessments for the contributions of Member States to the regular budget of the United Nations for 2025, 2026 and 2027.
3. In line with article 160 (2) (e) of the Convention, the scale of assessments relating to the administrative budget of the Authority is to be based on the scale of assessments used for the regular budget of the United Nations, adjusted for differences in membership between the Authority and the United Nations, taking into account the ceiling assessment rate of 22 per cent and the floor assessment rate of 0.01 per cent.
4. The Finance Committee is invited to review and determine, in accordance with article 160 (2) (e) of the Convention, that the scale of assessments of the Authority, for the second year of the financial period 2025–2026, should be adjusted to reflect the current scale of assessments for the regular budget of the United Nations for 2026, as presented in the annex to the present document.
